To the inhabitants of the School District of the **Town of Barnstead** qualified to vote in district affairs:

You are hereby notified to meet at the **Barnstead Elementary School** in said District on the **18<sup>th</sup> day of June 2018, at 6:00 o'clock in the evening** to act upon the Articles set forth in the Warrant:

**ARTICLE 1:**

To see if the School District will vote to approve the cost items included in the Collective Bargaining Agreement reached between the Barnstead School Board and the Barnstead Educational Association (BEA) which call for the following increase in salaries and benefits at the current staffing levels:

<u>Year</u>	<u>Estimated Increase</u>
2018-2019	\$ 89,864
2019-2020	\$119,431
2020-2021	\$125,662

And to further raise and appropriate the sum of **Eighty-Nine Thousand Eight Hundred Sixty-Four Dollars and No Cents (\$89,864.00)** for the 2018-2019 fiscal year, attributable to the increase in salaries and benefits over those of the appropriation at current staffing levels paid in the prior fiscal year in accordance with the most recent collective bargaining agreement. **Recommended** by the Barnstead School Board **Recommended** by the Barnstead Budget Committee. (Majority vote required) (\$.20 tax impact)

**ARTICLE 2:**

To see if the School District will vote to approve the cost items included in the Collective Bargaining Agreement reached between the Prospect Mountain School Board (JMA Alton/Barnstead) and the Prospect Mountain Teachers Association which call for the following increase in salaries and benefits at the current staffing levels:

<b>Year</b>	<b>Appropriate</b>	<b>Estimated Total Increase</b>
<b>2018-2019</b>	<b>\$59,583.00</b>	<b>\$128,634.00</b>
<b>2019-2020</b>	<b>\$43,362.00</b>	<b>\$ 93,613.00</b>
<b>2020-2021</b>	<b>\$47,888.00</b>	<b>\$103,385.00</b>

And to further raise and appropriate the sum of **Fifty-Nine Thousand Five Hundred Eighty-Three Dollars and No Cents (\$59,583.00)** for the 2018-2019 fiscal year, such sum representing **Forty-six and Thirty-two Hundredths Percent (46.32%)** of the total additional cost of **One Hundred Twenty-Eight Thousand Six Hundred Thirty-Four Dollars and Zero Cents**

(\$128,634.00) attributable to the increase in salaries and benefits over those of the appropriation at current staffing levels paid in the prior fiscal year in accordance with the most recent collective bargaining agreement. The adoption of this Article shall be contingent upon both the Alton (53.68%) and Barnstead (46.32%) Districts approving the cost items and raising and appropriating their respective sum of money to fund the costs items. **Recommended** by the Barnstead School Board. **Recommended** by the Barnstead Budget Committee (\$.13 tax impact)

To transact any other business which may legally come before this meeting.
